

## Fee decree for the Evangelical Reformed Church in Lauterbrunnen

### Casual fees

The following requirements at a wedding have to be fulfilled by the groom or the bride or both.

At funerals it has to be fulfilled by the defunct.

At baptism of minors the following policy is valid for one parent at least.

Expenses incurred, translation fees, additional musical accompaniment at the religious service or cost for time-consuming preparatory meetings will be charged in addition to the regular fees.

The fees are not payable by

- a) members of the Evangelical Reformed Church parish of Lauterbrunnen,
- b) non-residents of Lauterbrunnen who are members of a Swiss reformed church and were confirmed in the Evangelical Reformed Church parish of Lauterbrunnen,
- c) non-residents of Lauterbrunnen who are members of a Swiss reformed church and who one parent at least is member of the Evangelical Reformed Church parish of Lauterbrunnen,
- d) residents of Lauterbrunnen who are members of the Roman Catholic Church parish of Interlaken.

The fee tariff 1 is applicable to all members of a reformed church in Switzerland who do not reside in the parish of Lauterbrunnen.

The fee tariff 2 is applicable to all non-members of a reformed church in Switzerland.

## **Religious education**

The fee for children from class 7 onwards attending the religious education whose parents are non-members of the Evangelical Reformed Church of Lauterbrunnen may be invoiced to their parents.

Per child per schoolyear CHF 250.00

Children from class 6 and lower attend the religious education for free.
